<u>Overview</u>

Jefferson County Food Policy Council

The Jefferson County Food Policy Council ("Jeffco FPC" or "Food Policy Council") is a diverse stakeholder collaborative in Jefferson County, Colorado composed of local governments, nonprofit organizations, food and farm businesses, residents, and policymakers. Our mission is to increase equitable access to healthy, local, and affordable food and to support a sustainable community food system. The Council envisions Jefferson County as a food secure community with healthy food access for all residents, a vibrant and equitable farming infrastructure, a healthy ecosystem, and a thriving local food economy.

The Jeffco FPC started in 2015 as a project of Jefferson County Public Health and, as of December 2021, is now a fiscally sponsored project of the Trailhead Institute. Jeffco FPC staff and members have moved Jefferson County towards our vision through coordinated outreach events, educational programming, technical assistance, and policy change – all with an emphasis on developing a vibrant, equitable, local food system. Moving forward, the Jeffco FPC aims to build community power and leadership to promote policies that advance equity and sustainability within the food system to achieve our mission and vision.

Trailhead Institute

Trailhead Institute is a public health institute whose mission is to advance innovation and collaboration in public and environmental health. With this in mind, the Community Organizer will work with the Trailhead team to further the organization's mission and to operate in accordance with our organizational drivers of collaboration, capacity and justice. Furthermore, this position will ensure that a focus on inclusivity, diversity, and equity is incorporated throughout all components of this work.

The Community Organizer will work remotely with frequent in-person meetings and events in Jefferson County. The position requires a flexible schedule with some evenings and weekends depending on community events and meetings. The Community Organizer will conduct outreach to build the Council's stakeholder base, organize members around policy priorities, and plan training, education, and leadership development opportunities for Jeffco community members. The Community Organizer will report to the Director at Jefferson County Food Policy Council and Director of Projects and Partnerships at Trailhead Institute. The Community Organizer will work in collaboration with internal and external teams and partners. This position will be classified as a Coordinator at Trailhead.





Responsibilities:

- Mobilize and organize Council and community members to develop, influence, and support policy solutions centered in equity and aligned with the Food Policy Council's mission
- Build relationships with organizations, coalitions, and communities to:
 - o Expand the Food Policy Council's stakeholder base
 - o Increase engagement in the Food Policy Council
 - o Foster connections and collaboration across the food system
- Based on understanding of the Jeffco FPC community, develop an advocacy plan to:
 - o Build a powerful community-led coalition with stakeholders from across Jeffco
 - Educate members and community on the food and policy systems
 - Nurture leadership skills to promote voice, confidence, and power
 - o Center equity in Food Policy Council advocacy
- Develop a communication strategy to increase awareness of and engagement with the Food Policy Council and enhance information flow
- Plan training, education, and leadership development opportunities
- Coordinate workgroups and events as part of the Food Policy Council's operations
- Represent the Food Policy Council at community meetings, city council meetings, and events, which requires a flexible work schedule
- Partner with the Director to center Food Policy Council work in equity and community leadership

Skills

- Bilingual in Spanish strongly preferred
- Experience in community organizing, community leadership and/or community engagement through either lived experience (informal organizing), professional experience, or a combination
- Experience centering anti-racism and trauma-informed practices
- Understanding of community organizing processes, concepts, and techniques
- Ability to troubleshoot, take initiative, and be forward thinking in Jefferson County Food Policy Council's advocacy strategy
- Proficiency in Microsoft Office, Google applications, and Zoom, and comfortable learning new computer applications as needed
- Ability to adapt communication style to meet the needs of a variety of internal and external stakeholders
- Keen networking and problem-solving skills
- Demonstrated work history of coordinating and completing tasks independently and on time
- Excellent interpersonal and conflict resolution skills, able to resolve issues directly as they arise through the practice of ethical communication

- Commitment to building power among communities to fight for social, economic, and racial justice throughout Council structure and work
- Ability to meet people where they are and connect with people across a wide range of backgrounds, experiences, and interests
- Experience honoring the lived experiences of others in work and decision making
- Deep connection to Jefferson County preferred. This may include relationships with community members, organizations, and leaders
- Ability to focus, adapt and thrive in a hybrid remote work environment
- An entrepreneurial spirit, nimble and responsive in a dynamic, fast-paced environment
- Open to new ideas and willing to step outside of one's comfort zone, fail, learn from mistakes, and maintain a continuous improvement mentality
- A team player with a desire to promote this work in a professional and ethical manner
- Commitment to the mission, vision, values, drivers and strategic direction of the Jefferson County Food Policy Council and of Trailhead Institute

This is a LIMITED SERVICE position. The funding for this position is provided by limited-term funding and is dependent on that funding being maintained. Once the funding ends, the position will be discontinued, and there is no guarantee for additional employment with Trailhead Institute. Full-time employment is anticipated through **7/1/2024** with the optimism that the funding will continue.

 food system advocacy, education, and development.
- Co-creating mutually beneficial relationships where we can explore solutions to address issues that exist in our food system.
